ASCE Membership Prorated Dues & World Bank Discounts

Dues to join or reinstate ASCE membership are prorated monthly after January 31. Members joining after August 1 will join for the remaining months of the calendar year and the following year. Persons residing in countries classified by the World Bank as <u>low, low-middle, or upper-middle</u> <u>economies</u> may qualify for Society Dues discounts. The applicable World Bank discount will be applied to the current regular membership price of \$261 (USD) per calendar year.

ASCE members 28 years old and younger receive a 50% discount off of the current regular membership price.

New and reinstated members receive a prorated discount based on the month they join.
