Abstract

A proceedings containing papers presented at this conference will be produced from the manuscripts received from authors. Papers will be submitted through the conference web site <http://www.asce.org/conferences/ewri2006/index.cfm>.

Submission Deadline

Please submit your final paper by January 20, 2006. The Internet and related system hardware may be subject to slowdowns or other problems during periods of high use; therefore, please upload early in order to be sure you have a successful submission.

Submission Process

The submission process consists of a series of screens. You will be asked to enter a username and password and agree to ASCE's Copyright Transfer and Agreement terms. Then you may submit your paper to the system. **Do not submit your own PDF.** Your paper must be converted to a PDF document by our on-line system and you must review the PDF for formatting changes, which occasionally occur when a document is converted from one program to another.

The conversion will take approximately 15 minutes, depending on the size of the document, the speed of your Internet connection, and how fast the site is running.

If the conversion is successful, your screen will show two different hyperlinks for the original and converted files. You will be prompted to confirm that the paper meets with your approval. Before you agree, please review the paper to ensure that no conversion problems occurred. Print the paper to make sure that the conversion did not cause any format changes. **Remember your paper will not be edited or reformatted in any way following submission.** Once you have agreed, your paper will be formally submitted to ASCE. If you have changes to the paper later, you may re-supply it. Remember to check the format for every submission.

In order to convert your paper, you must have Adobe Acrobat Reader installed on your computer. If you do not have Adobe Acrobat Reader, you can download it for free at: <http://www.adobe.com/products/acrobat/readstep2.html>. In addition, this link will be available on the site's opening screen.

On any screen, **red asterisks** (*) indicate required information; you will not be allowed to continue the submission process without providing this information.

No paper can be included in an ASCE publication unless the author has agreed to the terms in the ASCE Copyright Transfer Agreement (CTA) form. A copy of the CTA is provided and you can sign off the agreement by clicking on either the "Yes, I agree" or the "U.S. Government employee" button.

Preparing for a Successful Submission

Be prepared to provide the following information to successfully submit your paper:

1. **File extension.** Submit the paper in one of the following formats: Microsoft Word, PostScript (.eps or .ps) with all fonts embedded, or Word Perfect. **Do not submit your paper as a PDF document.**
2. **File preparation.** *All* elements— e.g., text, graphics, fonts, photos—must be embedded in **one** file. **Proofread** your document for spelling, grammar, completeness, etc., before uploading. Your paper will *not* be edited or rewritten after submission.
3. **File location.** Know the location (pathname) of your paper (file) on your computer.

Format

Length. Papers should be 10 pages, including all text, graphics, and appendices.

Point size and font. Use 12 point type for text, captions, and author contact information. For type within figures or tables, the 12 point size is preferred. We recommend selecting a serif text font such as Times Roman. *Italics*, **bold**, and **bold italics** may be used; we recommend sticking to one "family" of typefaces.

Abstract. You must limit the abstract to the opening page of the manuscript. The abstract should present a concise statement of the scope, principal findings, and conclusions of the paper.

Headers and footers. Do not put any information in the header. The only acceptable content in the footer is a single page number.

Layout. All text must be single-spaced. Page design should be consistent throughout the paper.

Margin settings (see below) must contain *all* elements of the paper that will be reproduced (text, figures, tables, captions). Imagine a "box" whose **width** does not exceed 5.75" (14.5 cm) and **depth** does not exceed 9" (22.5 cm). Short pages are unsightly and waste space; try to "fill" the imaginary box on each page. Leave at least 1" (3 cm) *top* and *bottom* margins.

Figures and tables. All graphics (photos, line art, and tables) *must* be included electronically (embedded) within the document. If some graphics require scanning, you should have them scanned yourself and embed them in the document.

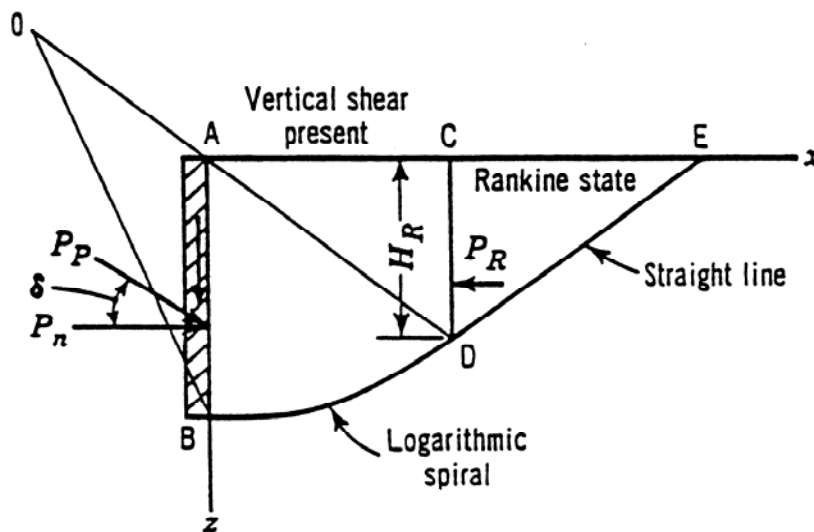


Figure 1. Sample line art illustration.

Illustrations should be numbered consecutively as they are presented (Figure 1, Figure 2, etc., and Table 1, Table 2, etc.). Each figure should be mentioned or “called out” before it appears. More than one figure may appear on a page.

Captions and legends. A descriptive caption, including figure number, should be placed directly *below* the illustration (see Figure 1). A descriptive legend, including table number, should be placed immediately *above* the table.

Style. The paper must be written in best possible technical and grammatical English. Titles should be concise and should describe the content of the paper. If you have a long title, please consider a **Title: Subtitle** format.

Mathematics. All mathematics must be embedded in the text. Equations need to be numbered *only* if they are referred to more than once. Stack numerators over denominators and leave one blank line between equations and text, and between two equations. For example:

$$\frac{q_r(C)}{\sigma_{vc}} = \frac{[K_0 + (1 - K_0)A_f] \sin \phi}{1 + (2A_f - 1) \sin \phi} \quad (3)$$

with $A_f = (\Delta u - \Delta \sigma_h) / (\Delta \sigma_v - \Delta \sigma_h)$ since $\Delta \sigma_h = \Delta \sigma_3$

Refer to equations in the text by (3) or Eq. 3. For equations in the text, use single-level expressions, e.g., $m_v = \Delta \varepsilon / \Delta \sigma'_v$, where $\Delta \varepsilon = \Delta e / (1 + e_0)$.

System of units. For more information about SI units, go to the U.S. Metric Association (USMA), Inc. site (<http://lamarcolostate.edu/%7Ehillger/>) or the National Institute of Standards and Technology (NIST) site (<http://physics.nist.gov/cuu/Units/index.html>).

Author contact information. A sample of author contact information is shown on the first page of these instructions. The following information may be provided for all authors of the paper: author's full name; Society membership grade; academic degrees or honorifics; current employment affiliation; postal and electronic mailing addresses; telephone and fax numbers.

References. All references should appear together at the end of the paper (see below). References are listed alphabetically by last name of the first author. When two or more references by the same author are listed, year of publication is taken into account, and the earliest work is listed first. Wherever reference is made in the text to an author's work, the author's name and year of publication should appear in parentheses. *We strongly recommend that superscripts **not** be used to denote references, as these numbers often appear too small to be read easily.* All listed references must be cited in text.

Permissions. If a figure, photograph, or table has been published previously, the *author* must obtain written approval from the original publisher. By submitting the paper, the author affirms that any necessary permissions have been obtained.

Authors take note: We strongly advise against trying to use Mapquest or Encarta material from the Internet because permission is difficult to obtain and often very expensive

Approvals. It is the author's responsibility to obtain all necessary approvals from the author's employer prior to submission of the paper. Once a paper has been uploaded, reviewed by the author, and officially submitted, it is not possible to edit the document.
